Wednesday, 4 Dec, until 12:00 (CET)	Member Parties to submit draft EMERGENCY RESOLUTIONS, including the supporting signatures (5 in total - via the online motion tool)	By noon (CET) of the Wednesday before the opening of the Congress
Friday, 6 Dec, until 13:00 <b>(CET)</b>	Member Parties to submit AMENDMENTS to the draft EMERGENCY resolutions (via the online motion tool, no supporting signatures needed)	By 13h (CET), two days before the vote
Wednesday, 22 January 2024	EGP office to send draft Congress minutes	6 weeks after Congress
